

Lamar Title I Parent Engagement Plan

PART I. General Expectations

Lamar agrees to implement the following statutory requirements:

E. the carrying out of other activities, such as those described in section 1118 of the ESEA.

PART II. Description of how Lamar will implement the required components of the campus Title I Parent Engagement Plan.

1. Lamar will take the following actions to involve parents in the joint development of its campus Parent Engagement Plan under section 1112 of the ESEA:

- Establish the campus Parent Engagement Advisory Council adequately represented by parents of attending children, administrators and Title I personnel. Other council members may include community members and students.
- Annually hold a meeting to review, discuss, and revise the school's Title I Parent Engagement Plan.
 - To increase parent involvement the meeting will be held several days and times to allow for parents who work to attend the meeting. Language support will be available upon parent request.

2. Lamar will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:

- Hold committee meetings, composed of parents and school staff, to review the Campus Improvement Plan.
 - We will invite parents who are already active on the campus and have them help us reach out to other parents to attend. We will provide language support if needed.
- Provide Title I, Part A school staff support in enhancing their School Campus Improvement Plans.
 - We will provide trainings to the teachers at the beginning of the year during staff development. We plan to reach out to AISD personnel for suggestions of trainings that are appropriate for our teachers.
- Administer the Title I campus Parent Engagement Survey designed to identify the type of support, information, and resources that parents' need included in their Campus Improvement Plan and campus Parent Engagement Plan to better support their children's education and become more involved in their school.

3. Lamar will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in the Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting and will encourage them to attend. These informative meetings may include, but are not limited to, the following:

- Meet the Teacher Night
- Back to School Night
- Table at registration and other evening events
- Language support will be provided if needed

4. Lamar will, in a timely manner, provide parents of participating children information about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of

academic assessment used to measure children's progress, and the proficiency levels students are expected to meet:

- Parent Meetings (language support if needed)
- Parent Conferences with teachers (ELSA app for language support)
- Report cards
- Phone call from teachers (ELSA app for language support)
- Notes from teachers

5. Lamar will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible. These may include, but are not limited to, the following:

- Parent Meetings
- Suggestion Box
- Parent Surveys
- Language support if needed

6. Lamar will provide each parent an individualized student report regarding the performance of their child on the state assessment in at least math, language arts and reading by:

- Report Cards
- School Messenger System
- Skyward
- Teacher conferences
- Language support if needed

7. Lamar will provide assistance to parents of children served by the school, as appropriate, on important topics. These may include, but are not limited to, the following: Reviewing and understanding the state's academic content standards.

- Reviewing and understanding the state's student academic achievement standards.
- Reviewing and understanding the state and local academic assessments including alternative assessments.
- The requirements of Title I, Part A.
- How to monitor their child's academic progress.
- How to work with educators.
- Other topics that received strong parent interest as reflected by the Title I school Parent Engagement Survey.

8. Lamar will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parent engagement. These may include, but are not limited to, the following:

- Literacy Week
- Math Night
- Science Night
- Discovery Center Night

9. Lamar will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools. These efforts may include, but are not limited to, the following:

- Parent Survey.
- Assistance from district PI on appropriate staff developments.

10. Lamar will, to the extent feasible and appropriate, coordinate and integrate TI parental engagement programs and activities with public preschool and other similar programs (e.g., Head Start, Parents as Teachers, etc.) that encourage and support parents in more fully participating in the education of their children. These efforts may include, but are not limited to, the following:

- Meet the Teacher Night before school starts.
- Tables at ECI parade if invited in the future.

11. Lamar will take the following actions to ensure that information related to the school, parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand. These may include, but are not limited to, the following:

- Interpreters
- Translators
- Language Line
- ELSA app

PART III. Discretionary Components of the Lamar Title I Parent Engagement Plan
